## PRELIMINARY MATTERS

On June 30, 1995, an application was filed by InVision Telecom, Inc. of Roswell, Georgia for authority to transfer the certificate previously issued to Communications Central, Inc., d/b/a InVision Telecom, Inc. to InVision Telecom, Inc. Notice of the application was published in the Omaha Daily Record on July 3, 1995. No protests were received; therefore, we will process this application pursuant to the Commission's Rule of Modified Procedure.

## OPINION AND FINDINGS

COMMunications Central, Inc., (hereinafter referred to as CCI) was certified to operate as a resale carrier in Nebraska pursuant to C-1142. The company was given authorization to provide intraLATA and interLATA interexchange services within the state of Nebraska. No departmental or formal complaints have been filed against the company since its certification.

Since becoming certified in Nebraska, CCI has undergone a corporate re-organization and has consequently created InVision Telecom, Inc., a wholly-owned subsidiary of CCI. InVision Telecom was incorporated in Georgia on April 14, 1995, and will operate the intrastate telecommunications services in Nebraska pursuant to the authority granted in C-1142.

Therefore, this application seeks a transfer of operating authority previously granted to CCI to its newly formed subsidiary, InVision Telecom. Operations will remain virtually unchanged with this transfer and InVision will provide service under its own name, corporate structure and tariff.

The authority issued to CCI in Application C-1142 is therefore revoked, as the company will not offer telecommunications services in Nebraska.

Upon consideration of the application, the governing statutes and rules, and being fully informed, the Commission is of the opinion and finds the application fair, reasonable and in the public interest.

## ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application C-1208 be, and it is hereby granted the certificate of public convenience and necessity previously issued to Communications Central, Inc., Inc. is hereby transferred to InVision InVision Telecom, Telecom, Inc.

IT IS FURTHER ORDERED that Invision Telecom, Inc. shall file, in accordance with the applicable statutes, an annual report with this Commission consisting of (a) a copy of any report filed with the Federal Communications Commission, the annual report to stockholders, and (c) for the State of combined interstate-intrastate basis, Nebraska ona investment in telephone plant and equipment located within the state, accumulated depreciation thereon, operating revenues, expenses and taxes before April 30th of each year.

IT IS FURTHER ORDERED that the certificate of authority previously issued to Communications Central, InVision Telecom, Inc. in C-1142 is hereby revoked.

IT IS FURTHER ORDERED that the applicant shall be exempt from compliance with Commission Rules 003.009A, 003.16C and 003.16D due to the nature of the service provided to correc-The same exemption request regarding Comtional facilities. mission Rule 03.16B is denied, except the provision mandating notice be posted of the procedure to access another company's operator.

IT IS FINALLY ORDERED that this order be and is hereby made the Commission's official certificate of authority to furnish the service authorized herein as a common carrier.
