PRELIMINARY MATTERS

On August 16, 1995, an application was filed by WorldTel Services, Inc. (WorldTel) of Irving, California, and Corporate Telemanagement Group (CTG), of Greenville, South Carolina, for authority to transfer assets from WorldTel to CTG. Notice of the application was published in the Omaha Daily Record on August 17, 1995. No protests were received; therefore, we will process this application pursuant to the Commission's Rule of Modified Procedure.

OPINION AND FINDINGS

WorldTel obtained a Certificate of Public Convenience and Necessity from the Commission pursuant to Application C-964 on March 9, 1993. No departmental or formal complaints have been filed against the company since its certification.

CTG is a South Carolina corporation with its principal place of business in Greenville, South Carolina. The Commission granted CTG a Certificate of Public Convenience and Necessity in Application C-932 on September 1, 1992 to provide intraLATA and interLATA services. Like WorldTel, no formal or departmental complaints have been filed against the company.

WorldTel has agreed to convey a portion of its assets to CTG, specifically (a) customer contracts, rights, lists records, billing and other information relating to WorldTel's customers; (b) sales agents' contracts, rights, lists, records, payment and other information regarding sales agents; and (c) and the exclusive right to use the trademark "Express" until December 31, 1995. The agreement is effective the date the Commission approves the authority sought herein.

On August 21, 1995, the Commission granted Application C-1198, which transferred authority of Corporate Telemanagement Group, Inc. to LCI Telemanagement Corporation. Thus, in the present application, the assets of WorldTel will be transferred to CTG; however, the ultimate transfer will be made to LCI International.

WorldTel will maintain its tariff and certification with the Commission. The company plans on remaining active in the telecommunications industry.

CTG anticipates a transition period of approximately, six month to fully integrate WorldTel's customers into its operations. CTG will continue to bill the former WorldTel customers under WorldTel's tariff, with bills that identify both WorldTel and CTG. During the transition, CTG will migrate these customers onto its tariff, grandfathering the WorldTel customers. Customers will be notified of the transaction and advised that they may select the carrier of their choice.

Upon consideration of the application, the governing statutes and rules, and being fully informed, the Commission is of the opinion and finds:

The transfer of assets belonging to WorldTel Services, Inc. of Irvine, California to Corporate Telemanagement Group of Greenville, South Carolina is fair and reasonable, is in the public interest and should be granted.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application C-1224 be, and it is hereby granted and the assets of WorldTel Services, Inc. are hereby transferred to Corporate Telemanagement Group and then to LCI Telemanagement.

IT IS FURTHER ORDERED that the parties shall continue to file for the year 1995, in accordance with the applicable statutes, an annual report with this Commission consisting of (a) a copy of any report filed with the Federal Communications Commission, (b) the annual report to stockholders, and (c) for the State of Nebraska on a combined interstate-intrastate basis, the investment in telephone plant and equipment located within the state, accumulated depreciation thereon, operating revenues, expenses and taxes by April 30, 1996.

IT IS FINALLY ORDERED that this order be and is hereby made the Commission's official certificate of authority to furnish the service authorized herein as a common carrier. Application No. C-1224
