The Nebraska Public Service Commission hereby requests the Applicants to answer the following Interrogatories, in writing and under oath, on or before thirty (30) days from the date hereof, pursuant to Nebraska Discovery Rules 26, 33, and 37, and Rule 016.11 of The Rules of Commission Procedure.

INSTRUCTIONS

(a) The Answer to each Interrogatory shall contain the composite knowledge of the Applicants.

(b) If the Applicants are unable, for any reason, to answer an Interrogatory fully and completely, state the reasons therefor in detail and answer the Interrogatory to the fullest extent possible.

(c) If the Applicants object to any Interrogatory and decline to provide the information requested, state the nature of the objection and the legal and factual basis for such objection.

INTERROGATORIES

1. Identify each and every person who provided information for or participated in the preparation of the Answers to these Interrogatories, and in regard to each such person, describe, by number, the Interrogatories for which such person supplied information.

2. State with specificity the experience that GSTNET, Inc. has in telecommunications, including a listing of each state in which it is certificated or has an application pending to provide telecommunications services.

3. Identify the person, company, address and telephone number that the Nebraska PSC should contact to resolve consumer questions and complaints.

4. Identify all changes, if any, that will be made with respect to the present rates, services and tariff provisions.

5. Identify what, if any, operational changes will be made if the requested transfer is approved.

6. Identify the applicant's underlying carrier.


11. Attach a copy of GSTNET's Articles of Incorporation.
