PRELIMINARY MATTERS

By application filed October 16, 1995, Allnet Communications Services Inc., of Washington D.C. seeks approval to do business as Frontier Communications Services. Notice of the application was published in the Omaha Daily Record, October 18, 1995 in accordance with the Commission's Rules of Procedure. No protests to the application were received. Therefore, we will process this application pursuant to the Commission's Rule of Modified Procedure (see Title 291, NAC Ch. 1, Rule 018.03).

O P I N I O N A N D F I N D I N G S

Upon consideration of the application, the governing statutes and rules and being fully informed, the Commission is of the opinion and finds:

Allnet Communications Services, Inc. was granted authority to provide intrastate interLATA and intraLATA interexchange telecommunications services in Nebraska pursuant to Application No. C-772. Since certification, no formal complaints have been filed against the company.

In C-1066, Frontier Communications Services was granted authority to provide intrastate interLATA and intraLATA interexchange telecommunications services in Nebraska. On June 20, 1995, Frontier was granted authority by this Commission to acquire Allnet pursuant to Application No. C-1188. Frontier hereby files this application for authority to reflect that Allnet will be doing business as Frontier Communications Services.

The name change will not alter the company's day-to-day operations, rates, services or management. No corporate personnel or structural changes will be necessary if this application is granted. Included in the application is a proposed tariff, reflecting the name change to Frontier. The tariff is in conformance with the Rules and Regulations of this Commission.
