PRELIMINARY MATTERS

By application filed January 19, 1996, Robert Cefail & Associates / American Inmate Communications, Inc. of Clearwater, Florida seeks authority to withdraw their Certificate of Public Convenience and Necessity within the state of Nebraska. Notice of the application was filed in the Omaha Daily Record on January 22, 1996. No protests to the application were received; therefore, we will process this docket pursuant to the Commission Rule of Modified Procedure.

OPINION AND FINDINGS

On December 2, 1991, the applicant, Robert Cefail & Associates American Inmate Communications, Inc. filed an application, C-911, with the Commission for authority to transact business as a reseller of interexchange telecommunications in the State of Nebraska. Notice of the application was published in the Omaha Daily Record on December 6, 1991. A hearing was held on the application on January 21, 1992 and authority was granted for the applicant to provide interexchange interLATA and intraLATA telecommunications services on February 11, 1992.

By letter dated January 12, 1996, Robert Cefail requested permission to withdraw its certificate of authority in Nebraska. The letter provides that Robert Cefail formerly operated an inmate telecommunications service provider; however, never deployed any facilities within Nebraska.

Robert Cefail seeks to withdraw its certificate, as it transferred its assets to Communications Central, d/b/a InVision Telecom, Inc. of Roswell, Georgia. Thus, the company no longer operates in Nebraska and does not need to have an active certificate or tariff on file.

The company has provided its annual financial report for the year 1995 and has no outstanding formal or informal complaints. Further, no departmental complaints are pending against the company. Application No. C-1284

After consideration of the request and being fully advised in the premises, the Commission is of the opinion and finds the request reasonable and that Robert Cefail & Associates / American Inmate Communications, Inc. of Clearwater, Florida may withdraw its Certificate of Public Convenience and Necessity issued in Application No. C-911.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application C-1284, filed by Robert Cefail & Associates / American Inmate Communications, Inc. be, and it is hereby, granted.

IT IS FURTHER ORDERED that the defendant shall not provide intrastate interexchange intraLATA and interLATA services in the state of Nebraska.
