PRELIMINARY MATTERS

By application filed March 13, 1996, Telstar Communications, Inc., d/b/a Telstar Long Distance of Evansville, Indiana seeks approval to change its name to OneStar Long Distance, Inc. Notice of the application was published in the Omaha Daily Record, March 15, 1996 in accordance with the Commission's Rules of Procedure. No protests to the application were received. Therefore, we process this application pursuant to the Commission's Rule of Modified Procedure (see Title 291, NAC Ch. 1, Rule 018.03).

O P I N I O N   A N D   F I N D I N G S

Upon consideration of the application, the governing statutes and rules and being fully informed, the Commission is of the opinion and finds:

Telstar Communications, Inc. was granted authority to provide intrastate interLATA and intraLATA interexchange telecommunications services in Nebraska pursuant to C-1071 on August 9, 1994. No formal or departmental complaints are pending against the company.

The application states the change in name does not involve any change in ownership or the business practices of the company. Further, the applications provides that customers will be notified of the name change through an insert in their monthly invoice.

The name change will not alter the company's day-to-day operations, services or management; therefore, customers should not experience any visible changes by approving this application. An amended Secretary of State certificate was enclosed with the application reflecting the change in name.

Based on the contents of the application, the request is reasonable, is in the public interest, and should be granted.
