PRELIMINARY MATTERS

By application filed August 19, 1996, XLConnect Services, Inc. f/k/a IntelliCom Solutions, Inc. of Exton, Pennsylvania seeks authority to operate under the name of XLConnect Services, Inc. within the State of Nebraska. Notice of the application was published in the Omaha Daily Record, August 21, 1996 in accordance with the Commission's Rules of Procedure. No protests to the application were received. Therefore, we process this application pursuant to the Commission's Rule of Modified Procedure (see Title 291, NAC Ch. 1, Rule 018.03).

O P I N I O N A N D F I N D I N G S

Upon consideration of the application, the governing statutes and rules and being fully informed, the Commission is of the opinion and finds:

IntelliCom Solutions, Inc. is a corporation existing under the laws of the State of Pennsylvania with its principal office located at 411 Eagleview Blvd; Exton, Pennsylvania. IntelliCom Solutions, Inc. was issued and continues to operate pursuant to a certificate of public convenience and necessity that was granted by the Commission in Application C-1225 on December 5, 1995.

The applicant recently became part of a new division of XLConnect Solutions, Inc. which filed an initial public offering in July, 1996. Applicant is a division of the new entity and the name changed from IntelliCom Solutions, Inc. to XLConnect Services, Inc. to keep the name in the same family.

Based on the contents of the application, the request is reasonable, is in the public interest, and should be granted.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-1402 be, and it is hereby granted and the current name of IntelliCom Solutions, Inc., is changed to XLConnect Services, Inc.



IT IS FURTHER ORDERED that the applicant file an updated tariff with the Commission within thirty (30) days reflecting the authorized change in name.


