OPINION AND FINDINGS

On September 19, 1996, the Nebraska Public Service Commission ("NPSC"), on its own motion initiated Application C-1416 to investigate GTE Telephone Operations cost studies and to establish rates for interconnection, unbundled elements, transport and termination, and resale services.

Notice of the filing of the docket was published pursuant to the provisions of the Commission's Rules and Regulations. Notice of the application appeared in the <u>Omaha Daily Record</u> on October 7, 1996.

On October 3, 1996, GTE Midwest Incorporated ("GTE") filed a motion with the Commission seeking an order protecting GTE Nebraska's confidential information contained in GTE Nebraska's Cost Studies filed in connection with the above-entitled docket.

All access, review, use and disclosure of the correspondence, documents, data, studies, methodologies or other information or materials designated by a party to this proceeding as proprietary (hereinafter referred to as "Confidential Information") shall be governed by the terms of this order.

It is likely that proprietary and confidential information will be provided in this proceeding, and that, absent the existence of this order, a significant risk of disclosing truly confidential material to parties will exist.

As a result, no confidential information shall be made available to anyone other than the Commission. However, access to any confidential information may be authorized by GTE, solely for the purposes of this proceeding, to those persons indicated by any party as being their experts in this matter. Any disputes concerning the above shall be brought before the Commission for a ruling.

The Commission intends to minimize the amount of "confidential" information so as to maximize the amount of public information. Therefore, any information that is deemed by GTE as "confidential" may be made available subject to the above conditions at the Omaha offices of McGrath, North, Mullin & Kratz, local counsel for GTE or by obtaining a copy from GTE directly. All parties that are allowed to examine the confidential material shall sign a protective agreement.

Upon consideration of the motion, and being fully advised, the Commission is of the opinion that GTE's request for an order protecting confidential information is fair and reasonable, is in the public interest, and should be granted.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the Motion for Protective Order made by GTE pursuant to Application No. C-1416 be, and it is hereby granted.
