O P I N I O N     A N D     F I N D I N G S

By application filed April 30, 1997, United Teleservices, Inc. d/b/a UTLD of Overland Park, Kansas, seeks authority to withdraw their Certificate of Public Convenience and Necessity within the state of Nebraska. Notice of the application was published in the Omaha Daily Record on May 1, 1997. No protests to the application were received; therefore, we will process this docket pursuant to the Commission Rule of Modified Procedure.

UTLD was granted its certificate of public convenience and necessity on April 26, 1988, pursuant to Application No. C-749. On April 30, 1997, UTLD requested permission to withdraw its certificate of authority in Nebraska.

The company no longer operates in Nebraska and does not need to have an active certificate or tariff on file. The company notified its customer base of the withdrawal of service via direct mail on January 31, 1997. Customers were not charged any "PIC" change charge as UTLD paid all such charges. No departmental complaints are pending against the company.

After consideration of the request and being fully advised, the Commission is of the opinion and finds the request reasonable and that United Teleservices, Inc. d/b/a UTLD of Overland Park, Kansas, may withdraw its certificate of public convenience and necessity issued in Application No. C-749.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application C-1536, filed by United Teleservices, Inc. d/b/a UTLD be, and it is hereby, granted.

IT IS FURTHER ORDERED that the certificate issued to United Teleservices, Inc. d/b/a UTLD pursuant to Application No. C-749 is withdrawn.
