BY THE COMMISSION:

Nedelco, Inc. and Hamilton Long Distance Company (HLDC) filed an application with the Commission on May 16, 1997 requesting authority to transfer the certificate of authority issued to Nedelco to provide interexchange services to HLDC. The applicants also request that such certificate be expanded to include the provisioning of interexchange telecommunications services statewide, including LATA 984. Notice of the application appeared in The Daily Record, May 21, 1997. No protests were filed; therefore, we will process this application pursuant to the Commission's rule of modified procedure.

OPINION AND FINDINGS

Nedelco was granted authority on September 10, 1991 to provide interexchange services in Nebraska, with the exception of intraLATA interexchange services in LATA 958, pursuant to Application No. C-893. Since that date, Nedelco has been engaged in the provision of such services in Nebraska. Nedelco exists primarily as a holding company of Hamilton Telephone Company, a local exchange carrier operating in central Nebraska. No formal or departmental complaints are pending with Nedelco.

HLDC is headquartered in Aurora, Nebraska and is in good standing with the Nebraska Secretary of State. HLDC has been organized to become an interexchange provider in Nebraska. Specifically, the company desires to provide intraLATA and inter-LATA interexchange services statewide, including the 958 LATA. HLDC agrees to provide interexchange services in accordance with the tariff presently on file for Nedelco.

Upon reviewing the application, HLDC has provided the requisite information and has demonstrated it is technically, financially and managerially qualified to provide interexchange services within the state of Nebraska, including the 958 LATA.
