On May 16, 1997, an application was filed by A.B.T.S. International Corp. d/b/a Intelnet (A.B.T.S.), of West Berlin, New Jersey, seeking authority to change its name to INTELNET Services of North America, Inc. (INTELNET). Notice of the application was published in the The Daily Record on May 21, 1997. No protests were received; therefore, this application has been administered pursuant to the Commission's rules of modified procedure.

A.B.T.S. is a privately-held corporation which was incorporated in the state of New Jersey in 1994. A.B.T.S. is certificated to operate as a resale carrier of telecommunications services within the state of Nebraska pursuant to Application C-1347.

A.B.T.S. seeks authorization to change the name on its certificate of convenience and necessity to INTELNET Services of North America, Inc. The new corporation, INTELNET, has the same owner as A.B.T.S. The proposed name change does not involve any change in the operations, control or ownership. Further, no change in rates, terms or conditions will be caused by the proposed name change. The certificate of public convenience and necessity issued to A.B.T.S. International Corp. d/b/a Intelnet should accordingly be changed to reflect the name INTELNET Services of North America, Inc.

Upon consideration of the application, the governing statutes and rules, and being fully informed, the Commission is of the opinion that the request should be granted.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application C-1546 be, and it is hereby, granted and that the certificate issued to A.B.T.S. International Corp. d/b/a Intelnet be changed to reflect the name INTELNET Services of North America, Inc.
