BY THE COMMISSION:

On June 27, 1997, an application was filed by Trescom USA, Inc. (Trescom) of Fort Lauderdale, Florida seeking approval of the purchase and acquisition of the assets of United States Digital Network, L.P. (USDN). Notice of the application was published in The Daily Record, June 30, 1997. No protests were filed; therefore, we process this application pursuant to the Commission's Rule of Modified Procedure.

O P I N I O N   A N D   F I N D I N G S

Trescom received a Certificate of Public Convenience and Necessity to provide intrastate telecommunications services on June 4, 1996 in Application C-1301. Currently, no formal or departmental complaints are pending against Trescom. USDN is authorized to provide intrastate telecommunications services in Nebraska pursuant to Application C-1082.

The application requests authority for Trescom to acquire certain assets used by USDN in the provision of telecommunications services. Assets include, but are not limited to USDN's customer base, letters of authorization, customer contracts, call detail records and customer files. Trescom would also acquire the "USDN" name.

While Trescom will continue to operate in Nebraska, USDN will no longer conduct business in Nebraska and asks that its certificate be revoked.

Trescom will bill the acquired customers under the rates, terms and conditions of USDN's tariff. Trescom will notify USDN's customers of the acquisition with billing inserts.

Upon consideration of the application, the governing statutes and rules, and being fully informed, the Commission is of the opinion and finds the assets described herein should be transferred from USDN to Trescom.
