## BY THE COMMISSION:

On October 15, 1997, an application was filed by InVision Telecom, Inc. (InVision) and Talton Invision, Inc. (Talton) of Roswell, Georgia and Grand Prairie, Texas, seeking approval for Talton to acquire the physical assets of InVision. Notice of the application was published in <a href="The Daily Record">The Daily Record</a>, on October 17, 1997. No protests were filed; therefore, we process this application pursuant to the Commission's Rule of Modified Procedure.

## OPINION AND FINDINGS

InVision received a Certificate of Public Convenience and Necessity to provide private payphone services on June 30, 1995, in Application C-1208. Talton is a wholly-owned subsidiary of Talton Holdings, Inc and does not currently possess a Certificate of Public Convenience and Necessity. However, Talton's parent, Talton Holdings is certificated to provide intrastate telecommunications services to correctional facilities in Nebraska pursuant to Application C-1453, granted January 7, 1997. No formal or departmental complaints are pending against either company.

The applicants request authority for Talton to acquire all the physical assets owned by InVision. Talton will transact business similar to InVision and limit its services to provisioning pay telephone services to correctional institutions.

The transfer of assets to Talton will allow the applicants to realize economic and marketing efficiencies. Talton will provide service under the same terms and conditions as are presently set forth in InVision's tariff.

Upon consideration of the application, the governing statutes and rules, and being fully informed, the Commission is of the opinion and finds the application should be granted.

## ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application C-1648 be, and it is hereby, granted.

IT IS FURTHER ORDERED that Talton Invision, Grand Prairie, Texas, be issued a Certificate of Public Convenience and Necessity to operate as an intrastate common carrier in Nebraska.

IT IS FURTHER ORDERED that Talton Invision, Inc. file, on or before April 30th of each year an annual report with the Commission.
