BY THE COMMISSION:

By application filed December 18, 1997, Business Calling Plan, Inc. of Las Vegas, Nevada, seeks authority to provide intraLATA and interLATA resold telecommunications services within the State of Nebraska. Notice of the application was published in The Daily Record, Omaha, Nebraska, on December 24, 1997, pursuant to the rules of the Commission. No protests were filed.

OPINION AND FINDINGS

Applicant is a privately-held corporation organized under the laws of the State of Nevada. Applicant has received authorization from the Nebraska Secretary of State to conduct business in Nebraska. Applicant plans to offer interexchange services on a resale basis to small business users throughout Nebraska. Applicant will not require advance payments or deposits. Applicant filed evidence demonstrating its financial, technical and managerial competency.

Interexchange reseller applications are subject to Commission jurisdiction under Neb. Rev. Stat. Sections 75-604 and 86-805 and Title 291 of the Commission's Rules and Regulations, Chapter 5, Rule 003.12. From examination of the application filed herein, the Commission finds applicant has provided all the information required by the Commission, possesses adequate financial resources to provide the proposed service, and possesses adequate technical and managerial competency to provide the proposed service. The application should be granted.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-1711 be, and it is hereby, granted and Business Calling Plan, Inc. of Las Vegas, Nevada, is authorized to operate as a resale carrier of intrastate interexchange intraLATA and interLATA telecommunications services within the state of Nebraska.

If these are not available, applicant shall submit a balance sheet and income statement for the previous year of operation, as well as the investment made in telephone plant and equipment located within the state, accumulated depreciation thereon, operating revenues and expenses, and taxes.

IT IS FURTHER ORDERED that applicant file its current tariff prior to offering service pursuant to the certificate granted in this order.

IT IS FINALLY ORDERED that this order be, and it is hereby made, the Commission's official certificate of authority to furnish the service authorized herein as a common carrier.
