OPINION AND FINDINGS

Applicant was organized under the laws of the state of California and is a wholly-owned subsidiary of Fidelity National Financial, Inc., a publicly-held corporation. Applicant has received authorization from the Nebraska Secretary of State to conduct business in Nebraska. Applicant plans to offer interexchange services throughout Nebraska. Applicant will utilize the facilities of AT&T or other certificated underlying carriers. Applicant filed evidence demonstrating its financial, technical and managerial competency.

Interexchange reseller applications are subject to Commission jurisdiction under Neb. Rev. Stat. Sections 75-604 and 86-805 and Title 291 of the Commission's Rules and Regulations, Chapter 5, Rule 003.12. From examination of the application filed herein, the Commission finds applicant has provided all the information required by the Commission, possesses adequate financial resources to provide the proposed service, and possesses adequate technical and managerial competency to provide the proposed service. The application should be granted.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-1737 be, and it is hereby, granted and ACS Systems, Inc. be, and is hereby, authorized to operate as a resale carrier of intrastate interexchange intraLATA and interLATA telecommunications services within the state of Nebraska.

IT IS FURTHER ORDERED that applicant file its current tariff prior to offering service pursuant to the certificate granted in this order.

IT IS FINALLY ORDERED that this order be, and it is hereby made, the Commission's official certificate of authority to furnish the service authorized herein as a common carrier.
