BY THE COMMISSION:

By application filed April 27, 1998, RRV Enterprises, Inc. (RRV) of Houston, Texas, sought and received approval from this Commission to undertake a series of transactions whereby RRV would have become a wholly-owned subsidiary of Imagitel, Inc. (Imagitel). Imagitel, in turn, would have become a wholly-owned subsidiary of Wavetech, Inc. (Wavetech). No protests were filed and the Commission gave its approval in Order C-1803 dated June 2, 1998.

On November 11, 1998, the Commission received notification from Counsel for RRV Enterprises, Wavetech, Inc., and Imagitel that the parties had abandoned the proposed reorganization. Consequently, RRV Enterprises, Inc. of Houston, Texas, will continue to operate as the resale carrier of interstate interexchange telecommunications services in the state pursuant to Application No. C-1361 as approved by the Commission on September 17, 1996.

RRV Enterprises, Inc. requests that the Commission vacate its prior order, C-1803, which approved the proposed reorganization.

O P I N I O N A N D F I N D I N G S

RRV is a privately-held Texas corporation with principal offices in Houston, Texas. RRV received a Certificate of Public Convenience and Necessity to operate as a resale carrier of intrastate interexchange telecommunications services in the state of Nebraska on September 17, 1996, in Application No. C-1361.

On June 2, 1998, the Commission approved a reorganization plan proposed by RRV Enterprises, Inc. to become a wholly owned subsidiary of Imagitel, Inc. which was to become a wholly owned subsidiary of Wavetech, Inc. The planned reorganization has since been abandoned by the parties. RRV Enterprises, Inc. asks the Commission to vacate the prior order, C-1803, which gave approval for the reorganization.

Based on the evidence, we find the request to vacate the order in Application No. C-1803 to be fair and reasonable and in the public interest. The request should be granted.


