BY THE COMMISSION:

On June 29, 1998, an application was filed by Intelnet services of North America, Inc. (Applicant) seeking authority to change its corporate name to Intelnet International Corp. Notice of the application was published in The Daily Record, Omaha, Nebraska, on July 2, 1998. No protests were filed. Therefore, we process this application pursuant to the Commission's Rule of Modified Procedure.

O P I N I O N A N D F I N D I N G S

Applicant received authority to operate as a resale common carrier of telecommunications services within the state of Nebraska, under the name A.B.T.S. International Corp. d/b/a Intelnet, from this Commission on August 27, 1996, pursuant to Application No. C-1347. Applicant received authority to change its name from A.B.T.S. International Corp. to Intelnet Services of North America, Inc. from this Commission on July 1, 1997, pursuant to Application No. C-1546. No formal or departmental complaints are pending against applicant.

Applicant requests authority to change its corporate name to Intelnet International Corp. On October 16, 1997, Intelnet Services of North America, Inc. legally changed its corporate name to Intelnet International Corp. in Delaware, the state of incorporation. There will be no change in the ownership or corporate structure of the company. Written notifications will be sent to all customers. Customers will continue to be billed under the name Intelnet. Applicant has obtained authority from the Nebraska Secretary of State to change its corporate name to Intelnet International Corp. in Nebraska.

Upon consideration of the application, the governing statutes and rules, and being fully informed, the Commission is of the opinion and finds the application should be granted.

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-1834 be, and it is hereby, granted and Intelnet Services of North America, Inc. is hereby authorized


to change its corporate name to Intelnet International Corp. in Nebraska.

IT IS FURTHER ORDERED that applicant file an updated tariff reflecting the corporate name change within thirty days from the date of this order.


