By application filed July 2, 1998, Telcorp, Ltd. of Hewlett, New York, seeks authority to provide intraLATA and interLATA resold telecommunications services within the State of Nebraska. Notice of the application was published in The Daily Record, Omaha, Nebraska, on July 7, 1998, pursuant to the rules of the Commission. No protests were filed.

OPINION AND FINDINGS

Applicant is incorporated under the laws of the State of New York and has received authorization from the Nebraska Secretary of State to conduct business in Nebraska. Applicant plans to offer switched and dedicated access "1+" long distance telecommunications services on a resale basis throughout the State of Nebraska. Applicant will utilize Sprint, AT&T, MCI, WorldCom or another certificated provider as its underlying carrier. Applicant filed evidence demonstrating its financial, technical and managerial competency.

Interexchange reseller applications are subject to Commission jurisdiction under Neb. Rev. Stat. Sections 75-604 and 86-805 and Title 291 of the Commission's Rules and Regulations, Chapter 5, Rule 003.12. From examination of the application filed herein, the Commission finds applicant has provided all the information required by the Commission, possesses adequate financial resources to provide the proposed service, and possesses adequate technical and managerial competency to provide the proposed service. The application should be granted.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-1835 be, and it is hereby, granted and Telcorp, Ltd. of Hewlett, New York, is authorized to operate as a resale carrier of intrastate interexchange intraLATA and interLATA telecommunications services within the state of Nebraska.

IT IS FINALLY ORDERED that this order be, and it is hereby made, the Commission's official certificate of authority to furnish the service authorized herein as a common carrier.
