BY THE COMMISSION:

An application was filed by Aliant Midwest, Inc. (AMI) seeking to provide local exchange services statewide in Nebraska, including the region served by Aliant Communications Company. Both companies are wholly-owned subsidiaries of Aliant Communications, Inc. By order dated July 7, 1998, the Commission denied the part of the application pertaining to AMI providing service in the territory presently served by Aliant Communications Company.

Similarly, a competitive affiliate of GTE, GTE-Communications Corporation (GTE-CC) has filed and received Commission approval of an interconnection agreement with GTE. GTE-CC utilized Section 252(i) of the Telecommunications Act of 1996 to utilize an interconnection agreement that was previously approved by the Commission for GTE and AT&T. While GTE-CC has not requested certification in Nebraska, it seems apparent that an application will be filed in the future.

As cited in the AMI order on July 7, 1998, we believe that further examination of this issue is warranted. Accordingly, we open this investigative docket to determine whether incumbent local exchange carriers should be able to establish affiliates to provide competitive local exchange services within their own territory. Parties may address all issues related to incumbent local exchange carriers establishing affiliates for the purpose of competing in-region.

We ask parties to comment on potential problems, such as customer confusion, preferential relationships, and marketing practices. We also ask them to comment as to what regulatory conditions, if any, should be imposed under this type of business relationship.
