BY THE COMMISSION:

On September 11, 1998, IXC Long Distance, Inc. (Applicant) of Austin, Texas, filed an application seeking authority to change its corporate name to IXC Communications Services, Inc. Notice of the application was published in The Daily Record, Omaha, Nebraska, on September 10, 1998. No protests were filed. Therefore, we process this application pursuant to the Commission's Rule of Modified Procedure.

O P I N I O N A N D F I N D I N G S

Applicant received authority to operate as a resale carrier of intrastate interexchange intraLATA and interLATA telecommunications services within the state of Nebraska, under the name IXC Long Distance, Inc. from this Commission on August 21, 1995, pursuant to Application No. C-1187. No formal or departmental complaints are pending against applicant.

On March 10, 1998, IXC Long Distance received authority from the Commission to assume control of Network Long Distance, Inc. pursuant to the approval of Application No. C-1744.

Applicant requests authority to change its corporate name to IXC Communications Services, Inc. A revised tariff has been submitted to the Commission to reflect the change in the company's name. There will be no change in the ownership or corporate structure of the company. Customers will be billed under the name of IXC Communications Services, Inc. (IXC-CSI) and will be notified of the name change of IXC through a "Notification to Customers" insert in customer billing statements. Applicant, incorporated under the laws of the state of Delaware, has obtained authority from the Nebraska Secretary of State to change its corporate name to IXC Communications Services, Inc. in Nebraska.

Upon consideration of the application, the governing statutes and rules, and being fully informed, the Commission is of the opinion and finds the application should be granted.


