BY THE COMMISSION:

On September 21, 1998, Business Calling Plan, Inc. (Applicant) of Las Vegas, Nevada, filed an application seeking authority to change its corporate name to Corporate Calling Services, Inc. Notice of the application was published in The Daily Record, Omaha, Nebraska, on September 23, 1998. No protests were filed. Therefore, we process this application pursuant to the Commission's Rule of Modified Procedure.

O P I N I O N A N D F I N D I N G S

Applicant received authority to operate as a resale carrier of intrastate interexchange intraLATA and interLATA telecommunications services within the state of Nebraska, under the name Business Calling Plan, Inc. of Las Vegas, Nevada, from this Commission on January 27, 1998, pursuant to Application No. C-1711. No formal or departmental complaints are pending against applicant.

Applicant requests authority to change its corporate name to Corporate Calling Services, Inc. There will be no change in the ownership or corporate structure of the company. The company is not currently operating in Nebraska and has no customer base in the state. Applicant filed a tariff pursuant to a grant of authority by this Commission on January 27, 1998, through Application No. C-1711. Applicant, incorporated under the laws of the state of Nevada, has obtained authority from the Nebraska Secretary of State to change its corporate name to Corporate Calling Services, Inc. in Nebraska.

Upon consideration of the application, the governing statutes and rules, and being fully informed, the Commission is of the opinion and finds the application should be granted.




