BY THE COMMISSION:

By application filed October 30, 1998, USX Consultants, Inc. (USX) of Pittsburgh, Pennsylvania, seeks authority to cancel, without prejudice, its Certificate of Public Convenience and Necessity within the state of Nebraska and to withdraw its tariff. Notice of the application was published in The Daily Record, Omaha, Nebraska, on November 2, 1998. No protests were filed; therefore, we process this application pursuant to the Commission's Rule of Modified Procedure.

O P I N I O N   A N D   F I N D I N G S

On April 22, 1994, USX filed Application No. C-1084 with the Commission for authority to transact business as a reseller of interexchange telecommunications in the state of Nebraska. A hearing was held on the application on July 19, 1994, and authority was granted for the applicant to provide intrastate interexchange intraLATA and interLATA telecommunications services on August 2, 1994.

By letter dated October 27, 1998, USX requested permission to cancel its authority to provide interstate and intrastate telecommunications services in this state and to have its tariff withdrawn.

USX has no customers in Nebraska and will not be offering interexchange telecommunications service in Nebraska.

The company is not subject of any outstanding formal or informal complaints. Further, no departmental complaints are pending against the company.

Upon consideration of the request and being fully advised in the premises, the Commission is of the opinion and finds the request reasonable and that USX Consultants, Inc. of Pittsburgh, Pennsylvania, may withdraw its Certificate of Public Convenience and Necessity issued in Application No. C-1084.


O R D E R

IT IS FURTHER ORDERED that the defendant shall not provide intrastate interexchange intraLATA and interLATA services in the state of Nebraska.




