BY THE COMMISSION:

By application filed November 12, 1998, Frontier Corporation (Frontier), Allnet Communications Services, d/b/a Frontier Communications Services (FCS), and Frontier International Inc. (FCI) seek authority for corporate reorganization of the Frontier companies. Notice of the application was published in The Daily Record, Omaha, Nebraska, November 13, 1998, pursuant to the Rules of the Commission. No protests were filed.

O P I N I O N A N D F I N D I N G S

Frontier is a publicly-held New York corporation with its principal offices in Rochester, New York. Frontier is the ultimate corporate parent of the entire Frontier family of companies, including FCS and FCI. Frontier, with its subsidiaries, is one of the nations leading telecommunications companies with over two million business, government, and residential customers.

FCS is a nationwide interexchange carrier that provides a full range of long distance services. FCA was acquired by Frontier in 1995 and was granted authority to provide resold interexchange telecommunications services in Nebraska on August 1, 1989, in Application No. C-772.

FCI is also a nationwide interexchange carrier that provides a full range of long distance services. FCI was granted authority to provide resold interexchange telecommunications services in Nebraska on July 19, 1994, in Application No. C-1066.

The reorganization will result in the transfer of the retail interexchange customer assets of FCI to FCS, with FCI thereafter providing only wholesale services. After the transfer, FCI retail interexchange customers will be served by the experienced and highly-trained personnel of FCS at rates, terms, and conditions comparable to those previously received. Customers of FCI will be notified of this change by letter explaining the new billing system.

O R D E R


IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-1939 be, and it is hereby, granted.




