OPINION AND FINDINGS

On November 23, 1998, NET-tel Corporation (NET-tel) and US West Communications, Inc. (US West) jointly filed an application seeking approval of their voluntarily-negotiated interconnection agreement. Notice of the application was published in The Daily Record on November 26, 1998. The Nebraska Independent Telephone Association filed comments on NET-tel and US West's interconnection agreement. No protests were filed; therefore, this application was processed pursuant to the Commission's Rule of Modified Procedure.

On January 5, 1999, the Commission approved a voluntarily-negotiated interconnection agreement between NET-tel and US West. Due to an oversight, the order did not contain a clause directing NET-tel to obtain a Certificate of Public Convenience and Necessity or to file a tariff with this Commission before offering telecommunications services in this state. Nebraska law and the Commission's rules provide that a common carrier must meet these requirements before it can offer service in the state.

Therefore, the Commission should enter a clarification order to direct that before NET-tel can provide basic local exchange services under this agreement, it must first receive a Certificate of Public Convenience and Necessity from this Commission authorizing it to provide local exchange service in Nebraska and must file a tariff in accordance with the provisions of Section 002.21 of the Commission's Telecommunication R. & Regs. tit. 291, ch. 5.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the voluntarily-negotiated interconnection agreement between NET-tel Corporation and US West Communications, Inc. be, and it is hereby, approved.

IT IS FURTHER ORDERED that before NET-tel can provide basic local exchange services under this agreement, it must first receive a Certificate of Public Convenience and

Necessity from this Commission authorizing it to provide local exchange service in Nebraska and must file a tariff in accordance with the provisions of Section 002.21 of Neb. Admin. R. & Regs. tit. 291, ch. 5.

IT IS FINALLY ORDERED that the executed interconnection agreement filed herein be, and it is hereby, made the official copy on file with the Nebraska Public Service Commission.
