BY THE COMMISSION:

By application filed November 24, 1998, Promise-Net International, Ltd. of Snellville, Georgia, seeks authority to operate as a resale carrier of interexchange telecommunications services within the state of Nebraska. Notice of the application was published in The Daily Record, Omaha, Nebraska, on November 26, 1998, pursuant to the rules of the Commission. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

OPINION AND FINDINGS

Applicant is a privately-held corporation organized under the laws of the state of Georgia and has received authorization from the Nebraska Secretary of State to conduct business in Nebraska. Applicant plans to offer switched and dedicated access "1+", "800", as well as prepaid and postpaid calling card telecommunications services throughout the state of Nebraska. Applicant will utilize TeleHub and USLD/LCI as its underlying carriers. Applicant filed evidence demonstrating its financial, technical and managerial competency.

Interexchange reseller applications are subject to Commission jurisdiction under <u>Neb. Rev. Stat.</u> secs. 75-604 and 86-805 and Title 291 of the Commission's Rules and Regulations, Chapter 5, Rule 003.12. From examination of the application filed herein, the Commission finds applicant has provided all the information required by the Commission, possesses adequate financial resources to provide the proposed service, and possesses adequate technical and managerial competency to provide the proposed service. The application should be granted.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-1954 be, and it is hereby, granted and Promise-Net International, Ltd. of Snellville, Georgia, is authorized to operate as a resale carrier of intrastate interexchange intraLATA and interLATA telecommunications services within the state of Nebraska.

IT IS FURTHER ORDERED that the applicant shall file, in accordance with the applicable statutes on or before April 30th of each year, an annual report with this Commission consisting of (a) a copy of any report filed with the Federal Communications Commission, (b) a copy of any annual report to stockholders and (c) a copy of the latest Form 10-K filed with the Securities and Exchange Commission. If these are not available, applicant shall submit a balance sheet and income statement for the previous year of operation, as well as the investment made in telephone plant and equipment located within the state, accumulated depreciation thereon, operating revenues and expenses, and taxes.

IT IS FURTHER ORDERED that applicant file its current tariff prior to offering service pursuant to the certificate granted in this order.

IT IS FINALLY ORDERED that this order be, and it is hereby made, the Commission's official certificate of authority to furnish the service authorized herein as a common carrier.
