BY THE COMMISSION:

On February 2, 1999, Cox Nebraska Telcom II, LLC (Applicant) of Omaha, Nebraska, filed an application seeking authority to change its name and transfer its assets and activities to Cox Nebraska Telcom, LLC. Notice of the application was published in The Daily Record, Omaha, Nebraska, on February 4, 1999. No protests were filed; therefore, we process this application pursuant to the Commission's Rule of Modified Procedure.

OPINION AND FINDINGS

Applicant received authority to provide interexchange telecommunications services from this Commission on October 15, 1997, pursuant to Application No. C-1625. Applicant also received authority to provide local excahnge telecommunications services from this Commission on December 10, 1996, pursuant to Application No. C-1359. No formal or departmental complaints are pending against applicant.

Applicant requests authority to change its name and to transfer its assets and activities, including its certificate, to Cox Nebraska Telcom, LLC. Applicant seeks this transfer for financial and tax purposes. Since both companies are wholly-owned subsidiaries of CoxCom, Inc., the net effect of the transfer will be that of merely a name change. The proposed name change and transfer will not noticeably impact Nebraska customers and will not change the technical, financial, or managerial fitness of the certificate holder. Applicant has obtained authority from the Nebraska Secretary of State to change its corporate name to Cox Nebraska Telcom, LLC.

Based upon the evidence, we find the application to be fair and reasonable and in the public interest. The application should be granted.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-1988 be, and it is hereby, granted and Cox Nebraska Telcom II, LLC is hereby authorized to change its corporate name to Cox Nebraska Telcom, LLC in Nebraska.
