OPINION AND FINDINGS

On March 26, 1999, an application was filed by Affinity Network Incorporated (Applicant) of Los Angeles, California, seeking authority for a name change to add the dba QuantumLink Communications to its certificate of operating authority. Notice of application was published in The Daily Record, Omaha, Nebraska, on March 30, 1999. On June 22, 1999, the Commission entered an order granting the applicant authority to use the dba QuantumLink Communications. After issuing its order, the Commission discovered that both the published notice and Commission order listed an incorrect location for the applicant's offices. Notice of the application, as corrected, was published in The Daily Record on June 30, 1999. No protests were filed; therefore, we process this application pursuant to the Commission's Rule of Modified Procedure.

Applicant received authority to operate as a resale carrier of intrastate interLATA and intraLATA telecommunications services from this Commission on December 10, 1991, pursuant to Application No. C-897. No formal or departmental complaints are pending against the applicant.

Applicant requests authority for a name change to add the dba QuantumLink Communications to its certificate of operating authority. The addition of the dba QuantumLink Communications will have no effect on the financial, technical, or managerial qualifications of the applicant. The current customers of the applicant will continue to receive services consistent with the rates, terms, and conditions of its tariff currently on file. Applicant has obtained authority from the Nebraska Secretary of State to do business as QuantumLink Communications in Nebraska.

Upon consideration of the application, the governing statutes and rules, and being fully informed, the Commission is of the opinion and finds the application should be granted.
