OPINION AND FINDINGS

On March 29, 1999, McLeodUSA Telecommunications Services, Inc. (McLeodUSA) and US West Communications, Inc. (US West) filed a joint application requesting authority to invoke Section 252(i) of the Telecommunications Act of 1996 (the Act) to utilize the arbitrated agreement between AT&T Communications of the Midwest, Inc. (AT&T) and US West. Notice of the application was published in The Daily Record on March 31, 1999. No protests were filed; therefore, this application has been administered pursuant to the Commission's modified procedure rule.

McLeodUSA obtained a certificate of public convenience and necessity to provide local exchange service from the Commission pursuant to Application No. C-1932 on January 13, Section 252(i) of the Act allows a certificated local exchange carrier to adopt a Commission-approved interconnection agreement. McLeodUSA wishes to establish an interconnection agreement with US West and accordingly seeks to adopt the The AT&T/US West AT&T/US West interconnection agreement. the Commission was approved by Application No. C-1385 and became effective August 8, 1997.

On May 28, 1997, the Commission added language to its mediation/arbitration policy (see Application No. C-1128, Progression Order No. 3) which sets forth the procedures to be followed for a Section 252(i) request. McLeodUSA has followed the procedures required by the Commission's policy.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application C-2023 be, and it is hereby, approved and McLeodUSA Telecommunications Services, Inc. is authorized to adopt the arbitrated agreement between AT&T Communications of the Midwest, Inc. and US West Communications, Inc.
