BY THE COMMISSION:

By application filed April 28, 1999, Cable & Wireless Global Markets, Inc. (Applicant) of Washington, D.C., seeks authority to operate as a reseller of interexchange telecommunications services and approval of its initial tariff. Notice of the application was published in The Daily Record, Omaha, Nebraska, on April 29, 1999. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

OPINION AND FINDINGS

Applicant is a corporation organized under the laws of the state of Delaware and has received authorization from the Nebraska Secretary of State to conduct business in Nebraska. Applicant plans to offer a full range of 1+ interexchange services throughout the state of Nebraska, including toll-free service, virtual private network service, and audio-conferencing. Applicant will utilize an underlying carrier certificated by this Commission. Applicant filed evidence demonstrating its financial, technical and managerial competency. Applicant's initial tariff defines all classes of service to be provided and includes rules and rates governing these services.

Interexchange reseller applications are subject to Commission jurisdiction under Neb. Rev. Stat. secs. 75-604 and 86-805 and Title 291 of the Commission's Rules and Regulations, Chapter 5, Rule 003.12. From examination of the application filed herein, the Commission finds applicant has provided all the information required by the Commission, possesses adequate financial resources to provide the proposed service, and possesses adequate technical and managerial competency to provide the proposed service. The Commission also finds applicant's initial tariff to be in compliance with Chapter 5, Rule 003.08 of the Commission's Rules and Regulations. The application should be granted.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-2039 be, and it is hereby, granted and Cable & Wireless Global Markets, Inc., of Washington, D.C., is authorized to operate as a reseller of interexchange telecommunications services within the state of Nebraska.

IT IS FURTHER ORDERED that the applicant shall file, in accordance with the applicable statutes on or before April 30th of each year, an annual report with this Commission consisting of (a) a copy of any report filed with the Federal Communications Commission, (b) a copy of any annual report to stockholders and (c) a copy of the latest Form 10-K filed with the Securities and Exchange Commission. If these are not available, applicant shall submit a balance sheet and income statement for the previous year of operation, as well as the investment made in telephone plant and equipment located within the state, accumulated depreciation thereon, operating revenues and expenses, and taxes.

IT IS FURTHER ORDERED that applicant's initial tariff as filed with the Commission be, and it is hereby, approved.

IT IS FURTHER ORDERED that applicant file its current tariff prior to offering service pursuant to the certificate granted in this order.

IT IS FINALLY ORDERED that this order be, and it is hereby made, the Commission's official certificate of authority to furnish the service authorized herein as a common carrier.
