BY THE COMMISSION:

On August 10, 1999, an application was filed by Tel-Save Inc., dba Group Network Services, Inc. and also dba TPC-The Phone Company of New Hope (Tel-Save), of New Hope, Pennsylvania, seeking authority to change its name to Talk.com Holding Corp., dba Group Network Services, Inc. and also dba TPC - The Phone Company of New Hope. Notice of the application was published in The Daily Record, Omaha, Nebraska, on August 11, 1999. No protests were filed; therefore, we process this application pursuant to the Commission's Rule of Modified Procedure.

O P I N I O N A N D F I N D I N G S

Tel-Save received authority to operate as a resale carrier of intrastate interexchange interLATA and intraLATA telecommunications services in Nebraska from this Commission on May 16, 1995, pursuant to Application No. C-1155. On April 29, 1997, pursuant to Application No. C-1461, Tel-Save was authorized to add the dba TPC-The Phone Company of New Hope.

Tel-Save requests authority to change its name in Nebraska to Talk.com Holding Corp., dba TPC-The Phone Company of New Hope and also dba Group Network Services, Inc. The proposed name change will not affect the company's financial, technical, or managerial capabilities. Tel-Save has received authority from the Nebraska Secretary of State to use the name Talk.com Holding Corp.

Upon consideration of the application, the governing statutes and rules, and being fully informed, the Commission is of the opinion and finds the application should be granted.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-2096 be, and it is hereby, granted and Tel-Save, Inc., dba Group Network Services, Inc. and also dba TPC-The Phone Company of New Hope is hereby authorized to change its name to Talk.com Holding Corp., dba Group Network Services, Inc. and also dba TPC-The Phone Company of New Hope.

IT IS FURTHER ORDERED that applicant file an updated tariff reflecting the change in name within thirty days from the date of this order.


