BY THE COMMISSION:

On November 22, 1999, an application was filed by Eclipse Telecommunications, Inc. (Applicant) of Issaquah, Washington, seeking authority to change its name to BroadWing Telecommunications, Inc. Notice of the application was published in The Daily Record, Omaha, Nebraska, on November 24, 1999. No protests were filed; therefore, this application is processed pursuant to the Commission Rule of Modified Procedure.

O P I N I O N A N D F I N D I N G S

Applicant received authority to operate as a resale carrier of intrastate interexchange telecommunications services from this Commission on September 13, 1994, pursuant to Application No. C-1081, under the name Network Long Distance, Inc. This Commission approved Network Long Distance, Inc.'s request to change its name to Eclipse Telecommunications, Inc. on November 24, 1998, in Application No. C-1905. No formal or departmental complaints are pending against the applicant.

Applicant requests authority to change its name in Nebraska to BroadWing Telecommunications, Inc. The proposed name change will not affect the applicant's financial, technical or managerial capabilities. Applicant has obtained authority from the Secretary of State to change its name to BroadWing Telecommunications, Inc.

Upon consideration of the application, the governing statutes and rules, and being fully informed, the Commission is of the opinion the application should be granted.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-2162 be, and it is hereby, granted and Eclipse Telecommunications, Inc. is authorized to change its name to BroadWing Telecommunications, Inc.

IT IS FURTHER ORDERED that applicant file an updated tariff reflecting the change in name within thirty days from the date of this order.

IT IS FURTHER ORDERED that this order be, and it is hereby made, the Commission's official certificate of authority, authorizing BroadWing Telecommunications, Inc. to furnish the service originally authorized in Application No. C-1081.


