BY THE COMMISSION:

On November 29, 1999, an application was filed by IXC Communications Services, Inc. (Applicant) of Austin, Texas, seeking authority to change its name to BroadWing Communications Services, Inc. Notice of the application was published in The Daily Record, Omaha, Nebraska, on December 1, 1999. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

O P I N I O N   A N D   F I N D I N G S

Applicant received authority to operate as a resale carrier of intrastate interexchange telecommunications services from this Commission on August 21, 1995, pursuant to Application No. C-1187, under the name IXC Long Distance, Inc. This Commission approved IXC Long Distance, Inc.'s request to change its name to IXC Communications Services, Inc. on November 24, 1998, in Application No. C-1904. No formal or departmental complaints are pending against the applicant.

Applicant requests authority to change its name in Nebraska to BroadWing Communications Services, Inc. The proposed name change will not affect the applicant's financial, technical, or managerial capabilities. Applicant has obtained authority from the Secretary of State to change its name to BroadWing Communications Services, Inc.

Upon consideration of the application, the governing statutes and rules, and being fully informed, the Commission is of the opinion the application should be granted.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-2167 be, and it is hereby, granted and IXC Communications Services, Inc. is authorized to change its name to BroadWing Communications Services, Inc.

IT IS FURTHER ORDERED that applicant file an updated tariff, effective January 4, 2000, and reflecting the change in name, within thirty days from the date of this order.

IT IS FURTHER ORDERED that this order be, and it is hereby made, the Commission's official certificate of authority, authorizing BroadWing Communications Services, Inc. to furnish the service originally authorized in Application No. C-1187.




