BY THE COMMISSION:

On November 29, 1999, an application was filed by Access One Communications Corp. (Access One) of Chicago, Illinois, f/k/a CLEC Holding Corp., OmniCall Acquisition Corp. and OmniCall, Inc. (OmniCall) of Greenville, South Carolina, seeking approval of transfer of control to Access One Communications Corp. Notice of the application was published in The Daily Record, Omaha, Nebraska, on December 1, 1999. No protests were filed; therefore, we process this application pursuant to the Commission's Rule of Modified Procedure.

O P I N I O N A N D F I N D I N G S

Access One is a privately-held New Jersey corporation headquartered in Ft. Lauderdale, Florida. Access One does not possess a certificate of operating authority from this Commission, however, it does, through a subsidiary, provide telecommunications services in several other states.

OmniCall is a privately-held South Carolina corporation that provides interexchange and local exchange telecommunications services throughout the nation. OmniCall received authority from this Commission to provide interexchange telecommunications services on July 8, 1999, pursuant to Application No. C-2049.

The transfer of control of OmniCall to Access One will be accomplished through a merger of OmniCall Acquisition Corp., a subsidiary of Access One created solely for the purpose of affecting this transaction, with and into OmniCall. Following the merger, OmniCall, as the surviving corporation, will become a direct and wholly-owned subsidiary of Access One.

Following the transfer, OmniCall will continue to provide services to its customers under its present authority. The transaction will be virtually unnoticed by OmniCall's customers, as they will continue to receive service under the same rates, terms and conditions they currently receive.

The proposed transfer satisfies the Commission's standards for judging such requests. Access One possesses sufficient technical and managerial expertise by way of its subsidiary corporations that actively provide telecommunications service in a number of states.

Furthermore, Access One possesses the financial ability to acquire OmniCall. The transaction is in the public interest because the combination of Access One and OmniCall will help to ensure that OmniCall provides high-quality service in Nebraska and, thus, should promote competition within the state.

Based on the evidence, we find the application to be fair and reasonable and in the public interest. The application should be granted.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-2168 be, and it is hereby, granted and the transfer of control of OmniCall, Inc. to Access One Communications Corp. is approved.
