BY THE COMMISSION:

On January 12, 1999, an application was filed by Telco Holdings, Inc., d/b/a Dial & Save (Applicant), of Reston, Virginia, seeking approval of a name change to Teleglobe Business Solutions, Inc. Notice of the application was published in The Daily Record, Omaha, Nebraska, on January 13, 1999. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

O P I N I O N A N D F I N D I N G S

Applicant derives its authority to provide interexchange and local exchange telecommunications services in Nebraska from Application Nos. C-1154 and C-1360, respectively. On June 11, 1997, pursuant to Application No. C-1532, the Commission transferred this authority from a related corporate entity directly to the applicant. No formal or departmental complaints are pending against the applicant.

Applicant requests authority to change its name in Nebraska to Teleglobe Business Solutions, Inc. The proposed name change will not affect the applicant's financial, technical or managerial capabilities. Applicant's current customers will receive notification of the name change and will not experience any disruption or inconvenience in their service as a result of the name change. Applicant has obtained authority from the Secretary of State to change its name to Teleglobe Business Solutions, Inc.

Upon consideration of the application, the governing statutes and rules, and being fully informed, the Commission is of the opinion the application should be granted.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-2198 be, and it is hereby, granted and Telco Holdings, Inc., d/b/a Dial & Save, is authorized to change its name to Teleglobe Business Solutions, Inc.

IT IS FURTHER ORDERED that the applicant file its revised tariff reflecting the proposed name change with the Commission within thirty days of the date of this order.




