OPINION AND FINDINGS

On March 3, 2000, a joint application was filed by WebLink Wireless, Inc. (WebLink) of Dallas, Texas, and US West Communications, Inc. (US West) of Denver, Colorado, seeking approval of their interconnection agreement pursuant to 47 USC Section 252(i). Notice of the application was published in The Daily Record, Omaha, Nebraska, on March 7, 2000. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

Section 252(i) of the Telecommunications Act of 1996 allows any telecommunications carrier to adopt a Commission-approved interconnection agreement. WebLink and US West wish to establish an interconnection agreement and accordingly seek to adopt the AirTouch Paging/US West interconnection agreement. The AirTouch Paging/US West agreement was approved by the Commission pursuant to Application No. C-2146 on November 30, 1999.

On May 28, 1997, the Commission added language to its mediation/arbitration policy (see Application No. C-1128, Progression Order No. 3) which sets forth the procedures to be followed for a Section 252(i) request. WebLink and US West have sufficiently complied with the procedures required by the Commission's policy.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-2239 be, and it is hereby, approved and WebLink Wireless, Inc. and US West Communications, Inc. are hereby authorized to adopt the interconnection agreement between AirTouch Paging and US West.

IT IS FURTHER ORDERED that the adoption of the AirTouch Paging/US West interconnection agreement by WebLink and US West became effective March 13, 2000.

IT IS FURTHER ORDERED that the executed interconnection agreement filed herein be, and it is hereby, made the official copy on file with the Nebraska Public Service Commission.
