O P I N I O N      A N D      F I N D I N G S

On December 1, 2000, a joint application was filed by Qwest Corporation (Qwest) of Denver, Colorado, and AT&T Communications of the Midwest, Inc. (AT&T) of Denver, Colorado, seeking approval of Amendment No. 1 to their wireline interconnection agreement. Notice of the application was published in The Daily Record, Omaha, Nebraska, on December 4, 2000. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

Pursuant to Section 252 of the Telecommunications Act of 1996 (the Act), Qwest and AT&T entered into an interconnection agreement, which was approved by the Commission on August 5, 1997, pursuant to Application No. C-1385. In the current application, Qwest and AT&T seek to amend the original agreement by replacing language regarding local number portability managed cuts. An executed copy of the amendment is contained within the application.

The amendment does not discriminate against any telecommunications carrier that is not a party to the agreement. Furthermore, the implementation of the amendment is consistent with the public interest, convenience and necessity.

Section 252(e) of the Act requires this Commission to review negotiated interconnection agreements to ensure they comply with Sections 251 and 252(d) of the Act, as well as all applicable state laws. Using those standards, the amendment filed December 1, 2000, should be approved.





