O P I N I O N A N D F I N D I N G S

On December 11, 2000, a joint application was filed by Integra Telecom of Nebraska, Inc. (Integra) of Beaverton, Oregon, and Qwest Corporation, f/k/a US West Communications, Inc. (Qwest) of Denver, Colorado, seeking approval of Amendment No. 4 to their interconnection agreement. Notice of the application was published in The Daily Record, Omaha, Nebraska, on December 13, 2000. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

On April 5, 2000, the original interconnection agreement between Qwest (then known as US West) and Integra was approved by this Commission, pursuant to Application No. C-2250. On July 18, 2000, pursuant to Application No. C-2319, the Commission approved Amendment Nos. 1 and 2 to the agreement. On August 29, 2000, pursuant to Application No. C-2359, the Commission approved Amendment No. 3 to the agreement. In the current application, Qwest and Integra seek to once again amend their agreement. An executed copy of the amendment is contained within the application.

The amendment does not discriminate against any telecommunications carrier that is not a party to the agreement. Furthermore, the implementation of the amendment is consistent with the public interest, convenience and necessity.

Section 252(e) of the Act requires this Commission to review negotiated interconnection agreements to ensure they comply with Sections 251 and 252(d) of the Act, as well as all applicable state laws. Using those standards, the amendment filed should be approved.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Amendment No. 4 to the interconnection agreement between Qwest Corporation, f/k/a US West Communications, Inc. and Integra Telecom of Nebraska, Inc. be, and it is hereby, approved.

IT IS FURTHER ORDERED that the executed amendment filed herein be, and it is hereby, made the official copy on file with the Nebraska Public Service Commission.
