BY THE COMMISSION:

By application filed March 19, 2001, James and Betty Jo Keisner, Fremont and residing in the Cedar Bluffs exchange of ALLTEL Communications (ALLTEL), seek authority to receive telephone service from the Fremont exchange served by Qwest Corporation (Qwest). Notice of the application was published in The Daily Record, Omaha, Nebraska, on March 21, 2001.

O P I N I O N   A N D   F I N D I N G S

ALLTEL and Qwest are local exchange carriers holding certificates of public convenience and necessity to provide local exchange service in their respective territories. The Keisners, who reside within the boundaries of ALLTEL's Cedar Bluffs exchange, request a boundary change so that they may receive local exchange service from Qwest's Fremont exchange. ALLTEL has notified the Commission that they are in agreement with Qwest regarding the proposed boundary change. The Keisners have agreed to compensate ALLTEL for the abandonment of ALLTEL's facilities as a result of the boundary change. Qwest requires no additional special construction charges, outside of the regularly tariffed service connection charges, to provide local telephone service to the Keisners.

Changes of a local exchange territory are governed by Neb. Rev. Stat. §§ 75-612 to 75-615. Section 75-612 states that only upon non-consent by all telephone carriers involved shall the Commission hold a public hearing in the application. With no protest filed by any party and with each of the affected local exchange carriers consenting to the boundary change, the Commission processes this application administratively and without a public hearing.

O R D E R


IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-2499 be, and it is hereby, granted.
