## BY THE COMMISSION:

By application filed December 12, 2001, PNV.net, Inc., f/k/a/Park 'N View, Inc. (PNV.net) of Duluth, Georgia, seeks authority to voluntarily withdraw its resale common carrier certificate of authority, granted in Application Nos. C-1811 and C-2131 and withdraw its tariff filed with the Commission. Notice of the application was published in <u>The Daily Record</u>, Omaha, Nebraska, on December 13, 2001. No protests were filed; therefore, we process this application pursuant to the Commission's Rule of Modified Procedure.

## OPINION AND FINDINGS

PNV.net was authorized by this Commission to operate as a resale carrier of telecommunications services in Nebraska on May 11, 1998, pursuant to Application No. C-1811. On September 30, 1999, pursuant to Application No. C-2131, authorization was granted to change its name from Park 'N View, Inc., to PNV.net, Inc.

By letter dated December 11, 2001, PNV.net gave notice that it currently wishes to discontinue service in Nebraska and, therefore, requests that its certificate to provide such service be withdrawn. PNV.net currently has no customers in Nebraska. Thus, no customer notification is necessary.

Upon consideration of the request and being fully advised, the Commission finds the request to be reasonable and finds that PNV.net may withdraw the certificate previously issued to it in Application Nos. C-1811 and C-1093.

## ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-2640 be, and it is hereby, granted and the Certificate of Public Convenience and Necessity of PNV.net, Inc. is withdrawn.
