O P I N I O N A N D F I N D I N G S

On September 26, 2002, a joint application was filed by Qwest Corporation (Qwest) of Denver, Colorado, and MCImetro Access Transmission Services, LLC (MCImetro) of Englewood, Colorado, seeking approval of a line sharing, unbundled packet switching, unbundled network element-platform (UNE-P) line splitting, change of law and loop splitting amendment to the interconnection agreement previously granted in Application No. C-2257. Notice of the application was published in The Daily Record, Omaha, Nebraska, on September 30, 2002. No protests were filed; therefore, this application is processed pursuant to the Commission's rule of modified procedure.

Pursuant to Section 252(i) of the Telecommunications Act of 1996 (the Act), Qwest and MCImetro entered into an interconnection agreement, which was approved by the Commission on April 11, 2000, in Application No. C-2257. In the current application, Qwest and MCImetro seek to amend the original agreement by adding terms, conditions and rates for line sharing, unbundled packet switching, UNE-P line splitting and loop splitting.

The amendment does not discriminate against any telecommunications carrier that is not a party to the agreement. Furthermore, the implementation of the amendment is consistent with the public interest, convenience and necessity.

Section 252(e) of the Act requires this Commission to review negotiated interconnection agreements to ensure they comply with Sections 251 and 252(d) of the Act, as well as all applicable state laws. Using those standards, the amendment filed September 26, 2002, should be approved.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the amendment to the interconnection agreement between Qwest Corporation and MCImetro Access Transmission Services, LLC, be, and it is hereby, approved.

IT IS FURTHER ORDERED that the executed amendment filed herein be, and it is hereby, made the official copy on file with the Nebraska Public Service Commission.
