BY THE COMMISSION:

On September 30, 2002, a joint application was filed by HJN Telecom, Inc. (HJN) of Duluth, Georgia, and Reliant Communications, Inc. (Reliant) of Lake Mary, Florida, seeking authority for approval of a stock purchase agreement and a name change to Reliant Communications, Inc. Notice of the application was published in The Daily Record, Omaha, Nebraska, on October 2, 2002. No protests were filed; therefore, this application is processed pursuant to the Commission's rule of modified procedure.

OPINION AND FINDINGS

The Parties:

HJN is a Georgia corporation with its headquarters in Duluth, Georgia. HJN was authorized by this Commission to transact the business of a reseller of telecommunications services pursuant to Application No. C-2020 on May 4, 2000.

Lisa Rogers is an individual resident of the state of Florida having her principal office in Lake Mary, Florida.

Description of the Transaction:

Ms. Rogers will acquire 100 percent of the outstanding and issued shares of stock of HJN from Herb Newton by virtue of the purchase agreement. HJN shall continue to operate as a regulated entity pursuant to HJN's present certifications, registrations, tariff requirements and rate structures, or on an unregulated basis, as provided by and pursuant to applicable law. Following the consummation of the transaction, HJN will change its name to Reliant Communications, Inc. The practical effect of the transaction is a change of ownership of the common stock of HJN. HJN will continue to operate in all respects as HJN presently operates.
