BEFORE THE COMMISSION:

On February 19, 2004, an application was filed by United Telephone Company of the West, d/b/a Sprint (Sprint) of Overland Park, Kansas, seeking approval of its Commercial Mobile Radio Service (CMRS) Interconnection Agreement with Tracy Corporation II (Tracy), of Gering, Nebraska. Notice of the application was published in The Daily Record, Omaha, Nebraska, on February 23, 2004. No protests were filed; therefore, this application is processed pursuant to the Commission's rule of modified procedure.

Pursuant to Section 252(i) of the Telecommunications Act of 1996 (the Act), Sprint and Tracy entered into a CMRS interconnection agreement arrived at through voluntary negotiations. The parties choose to adopt the CMRS interconnection agreement between Sprint and Sprint Spectrum L.P., a Delaware Limited Partnership, as agent for Wirellessco, LP, a Delaware Limited Partnership and Sprintcom, Inc., a Kansas Corporation and Cox Communications PCS, L.P., a Delaware Limited Partnership and APC PCS, L.L.C. a Delaware Limited Partnership and Phillieco, L.P., a Delaware Limited Partnership, all foregoing entities jointly d/b/a Sprint PCS, which was approved by the Commission at Application No. C-2849 on January 22, 2003; and Amendment No. 1 to the adopted agreement, which was approved by the Commission on March 20, 2004, pursuant to Application No. C-3127. An executed copy of this agreement is contained within the application.

Neither the agreement nor any portion thereof discriminates against any telecommunications carrier. Furthermore, the implementation of the agreement is consistent with the public interest, convenience and necessity.

Section 252(e) of the Act requires this Commission to review negotiated interconnection agreements to ensure they comply with Sections 251 and 252(d) of the Act, as well as all applicable state laws. Using those standards, the CMRS interconnection agreement should be approved.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the CMRS interconnection agreement between United Telephone Company of the West, d/b/a Sprint, and Tracy Corporation II, be, and it is hereby, approved.

IT IS FURTHER ORDERED that the CMRS interconnection agreement filed herein be, and it is hereby, made the official copy on file with the Nebraska Public Service Commission.
