## OPINION AND FINDINGS

On February 19, 2004, an application was filed by United Telephone Company of the West, d/b/a Sprint (Sprint) of Overland, Kansas, seeking approval of its Amendment No. 1 to their Commercial Mobile Radio Service (CMRS) interconnection agreement with Sprint Spectrum L.P., a Delaware Partnership, as agent for Wirelessco, LP, a Delaware Limited Partnership and Sprintcom, Inc., a Kansas Corporation and Cox Communications PCS, L.P., a Delaware Limited Partnership and APC PCS, L.L.C. a Delaware Limited Partnership and Phillieco, L.P., a Delaware Limited Partnership, all foregoing entities jointly d/b/a Sprint PCS (Sprint PCS), previously granted in Application No. C-2849. Notice of the application was published in The Daily Record, Omaha, Nebraska, on February 23, 2004. protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

Pursuant to Section 252(a) of the Telecommunications Act of 1996 (the Act), Sprint and Sprint PCS entered into a CMRS interconnection agreement, which was approved by the Commission on January 22, 2004, in Application No. C-2849. In the current application, Sprint and Sprint PCS seek to amend the original agreement. Executed copies of the amendment are contained within the application.

The amendment does not discriminate against any telecommunications carrier. Furthermore, the implementation of the amendment is consistent with the public interest, convenience and necessity.

Section 252(e) of the Act requires this Commission to review negotiated interconnection agreements to ensure they comply with Sections 251 and 252(d) of the Act, as well as all

applicable state laws. Using those standards, the amendment to the CMRS interconnection agreement should be approved.

## ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the amendment to the CMRS interconnection agreement between United Telephone Company of the West, d/b/a Sprint and Sprint PCS, be, and it is hereby, approved.

IT IS FURTHER ORDERED that the executed amendment filed herein be, and it is hereby, made the official copy on file with the Nebraska Public Service Commission.
