## BEFORE THE COMMISSION:

On April 22, 2004, Qwest Corporation (Qwest) of Denver, Colorado, filed an application seeking approval of its Statement of Generally Available Terms and Conditions for Interconnection Unbundled Network Elements, Ancillary Services, and Resale of Telecommunication Services with Comtech21, L.L.C. (Comtech21) of Wallingford, Connecticut. Notice of the application was published in <a href="The Daily Record">The Daily Record</a>, Omaha, Nebraska, on April 27, 2004. No protests were filed; therefore, this application is processed pursuant to the Commission's rule of modified procedure.

Pursuant to Section 252(i) of the Telecommunications Act of 1996 (the Act), Qwest and ComTech21 entered into an interconnection and resale agreement arrived at through voluntary negotiations. The parties choose to adopt Qwest's Statement of Generally Available Terms and Conditions for Interconnection, Unbundled Network Elements, Ancillary Services, and Resale of Telecommunication Services (SGAT). An executed copy of this agreement is contained within the application.

Neither the agreement nor any portion thereof discriminates against any telecommunications carrier. Furthermore, the implementation of the agreement is consistent with the public interest, convenience and necessity.

Section 252(e) of the Act requires this Commission to review negotiated interconnection agreements to ensure they comply with Sections 251 and 252(d) of the Act, as well as all applicable state laws. Using those standards, the SGAT interconnection and resale agreement should be approved.

## ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the Statement of Generally Available Terms and

Conditions for Interconnection Unbundled Network Elements, Ancillary Services, and Resale of Telecommunication Services agreement between Qwest Corporation and ComTech21, L.L.C., be, and it is hereby, approved.

IT IS FURTHER ORDERED that the executed SGAT inter-connection and resale agreement filed herein be, and it is hereby, made the official copy on file with the Nebraska Public Service Commission.
