BEFORE THE COMMISSION:

On May 6, 2004, an application was filed by Qwest Communications, Inc. (Qwest) of Denver, Colorado, seeking approval of its Statement of Generally Available Terms and Conditions for Interconnection, Unbundled Network Elements, Ancillary Services and Resale of Telecommunications Services with ACN Communications, Inc. (ACN), Farmington Hills, Michigan. Notice of the application was published in The Daily Record, Omaha, Nebraska, on May 10, 2004. No protests were filed; therefore, this application is processed pursuant to the Commission's rule of modified procedure.

Pursuant to Section 252(i) of the Telecommunications Act of 1996 (the Act), Qwest and ACN entered into an Interconnection, Unbundled Network Elements, Ancillary Services, and Resale of Telecommunications Services Agreement arrived at through voluntary negotiations. An executed copy of this agreement is contained within the application.

Section 252(e) of the Act requires this Commission to review interconnection agreements adopted by negotiation or arbitration to ensure they comply with Sections 251 and 252(d) of the Act, as well as all applicable state laws. Using those standards, the Interconnection, Unbundled Network Elements, Ancillary Services, and Resale of Telecommunications Services Agreement filed on May 6, 2004, should be approved.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the Statement of Generally Available Terms and Conditions for Interconnection, Unbundled Network Elements, Ancillary Services and Resale of Telecommunication Services between Qwest Communications, Inc., and ACN Communications Services, Inc., be, and it is hereby, approved.

IT IS FURTHER ORDERED that the executed interconnection agreement filed herein be, and it is hereby, made the official copy on file with the Nebraska Public Service Commission.
