On March 10, 2009, the Nebraska Public Service Commission (Commission) awarded Nebraska Internet Enhancement Fund (NIEF) grant to the Village of Bushnell in the amount of **\$10,000**.

The Village of Bushnell filed its signed Grant Agreement and Notice of Commencement on May 19, 2009.

On July 20, 2009, the Village of Bushnell submitted its Final Completion Report and supporting documentation. Bushnell requested payment of **\$10,142.73** in grant funds. Pursuant to the Grant Agreement, Bushnell opted for a lump sum payout of grant funds upon completion of the grant project. The Village of Bushnell has not to date received any grant funds. The Commission finds that final payment in the amount of **\$10,000** should be made to the Village of Bushnell.

The Village of Bushnell shall also submit, pursuant to Section 4.05 of the Grant Agreement, a Project Impact Report six (6) months from the date of completion of the project, July 9, 2009. The Report shall outline the benefits received from individuals, businesses, and community agencies as a result of the Project, the number of individuals, businesses, and community agencies using the services installed and estimates regarding the sustainability and growth of the Project.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that final payment in the amount of **\$10,000** in NIEF grant funds shall be made to the Village of Bushnell.

IT IS FURTHER ORDERED that the Village of Bushnell shall no later than **January 11, 2009**, also submit, pursuant to Section 4.05 of the Grant Agreement, a Project Impact Report.
