BEFORE THE COMMISSION:

On June 7, 2004, an application was filed by Qwest Corporation (Qwest) of Denver, Colorado, seeking approval of its Statement of Generally Available Terms and Conditions for Interconnection, Unbundled Network Elements, Ancillary Services, and Resale of Telecommunications Services with 1-800-Reconex Inc., d/b/a USTel (USTel) of Hubbard, Oregon. Notice of the application was published in The Daily Record, Omaha, Nebraska, on June 9, 2004. No protests were filed; therefore, this application is processed pursuant to the Commission's rule of modified procedure.

Pursuant to Section 252(i) of the Telecommunications Act of 1996 (the Act), Qwest and USTel entered into an interconnection and resale agreement arrived at through voluntary negotiations. The parties chose to adopt Qwest's Statement of Generally Available Terms and Conditions for Interconnection, Unbundled Network Elements, Ancillary Services, and Resale of Telecommunications Services Agreement (SGAT). An executed copy of this agreement is contained within the application.

Neither the agreement nor any portion thereof discriminates against any telecommunications carrier. Furthermore, the implementation of the agreement is consistent with the public interest, convenience and necessity.

Section 252(e) of the Act requires this Commission to review interconnection agreements adopted by negotiation or arbitration to ensure that they comply with Sections 251 and 252(d) of the Act, as well as all applicable state laws. Using those standards, the SGAT filed on June 7, 2004, should be approved.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the Statement of Generally Available Terms and Conditions for Interconnection, Unbundled Network Elements, Ancillary Services, and Resale of Telecommunication Services between Qwest Communications, Inc., and 1-800-Reconex Inc., d/b/a USTel, be, and it is hereby, approved.

IT IS FURTHER ORDERED that the executed interconnection agreement filed herein be, and it is hereby, made the official copy on file with the Nebraska Public Service Commission.
