BY THE HEARING OFFICER:

August 5, 2004, the Commission held a prehearing conference in the above-captioned matter. The following parties appeared through their respective legal counsel: Time Warner Cable Information Services, LLC d/b/a Time Warner Cable (Time Warner); Southeast Nebraska Telephone Company; Rural Independent Companies; Hemingford Cooperative Telephone Company; Nebraska Telecommunications Association; Alltel Nebraska, Inc.; Benkelman Telephone Company; Arapahoe Telephone Company; Cozad Telephone Company; Curtis Telephone Company; Diller Telephone Company; Glenwood Telephone Membership Corporation; Keystone-Arthur Telephone Company; Wauneta Telephone Company; Hartman Telephone Company; Mainstay Communications, and Qwest. AT&T and (Nebraska Technology & Telecommunications (NT&T) were also on telephone bridge. The Hearing Officer entered a Prehearing Conference Order on August 6, 2004, that set forth a procedural schedule for processing this application. It has come to the Hearing Officer's attention that the original hearing date of September 24, 2004, could, with agreement of the parties, be moved up one week to September 17, 2004. This Modified Prehearing Conference Order is entered to change the hearing date and the deadlines for discovery and pre-filed testimony.

- 1. Schedule: The following schedule should be established and should govern the Commission's consideration of this docket:
 - a. Parties should have until August 19, 2004, to prepare and serve on the other parties all discovery. Discovery should be limited in scope and time. All parties including the Commission staff are jointly limited to 25 interrogatories and/or production requests.
 - b. Time Warner should have until **September 1, 2004,** to respond to all discovery.

- c. Time Warner should have until 5:00 p.m. CDT, September 1, 2004, to serve all parties and file with the Commission copies of its pre-filed testimony and exhibits.
- d. All other parties should have until 5:00 p.m. CDT, September 10, 2004, to serve all parties and file with the Commission pre-filed testimony and exhibits.
- e. The hearing on this matter will be held on **September 17, 2004,** at 9:00 a.m. in the Commission Library.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the proceeding in the above-captioned matter shall be conducted in conformity with the foregoing paragraphs of this Modified Prehearing Conference Order.
