BY THE COMMISSION:

The Nebraska Public Service Commission (Commission) hereby opens the above-captioned docket, on its own motion, to investigate the impacts on carriers with facilities or numbering resources within Nebraska resulting from the implementation of a request by the Department of Navy (DON) for a nationwide overlay, described more fully below.

On October 11, 2004, the DON submitted Issue Statement 459 to the Industry Numbering Committee (INC) for consideration. The Issue requested the DON be granted one (1) single Number Plan Area (NPA), (366) to manage and provide for its own use with its numerous services providers. This NPA would be for exclusive use of the DON and would be a geographic overlay NPA for the United States portion of the Country Code 1 NPAs. All current DON number resources would be returned to their service providers within the affected area and potentially could be returned to NANPA once the conversion to NPA 366 is completed.

On November 4, 2004 the Department of the Navy's INC Issue was presented to the North American Numbering Council (NANC) who instructed INC to review the request for technical feasibility and report back to the NANC as to whether the submission is technically feasible and does not cause technical problems for the existing telecommunications numbering plan. The INC is not to review the business case or policy components of this request. As of this date the INC is still investigating the technical feasibility of the DON request.

In various presentations on this request the DON has indicated the need is driven by Command and Control issues, increased mobility of units comprising the DON, and "homeland security issues". The dedicated numbering resources would be used for all DON wireline, wireless, fax, pager, inbound modem, and VoIP applications. The DON intends that all numbers would be

reachable from any telephone on the public switched telephone network (PSTN) as a local call.

Implementation of the DON request potentially impacts both the citizens of Nebraska and the telecommunications carriers serving Nebraska. Therefore, the Commission staff is soliciting input from all certificated carriers with facilities in Nebraska or certificated carriers using numbering resources assigned to Nebraska Area Codes 308 or 402 on the following topics. This list is not considered all-inclusive and carriers should feel free to identify and respond to other issues or concerns.
