## BY THE HEARING OFFICER:

On October 28, 2005 an application was filed by Alltel Communications of Nebraska, Inc., Little Rock, Arkansas, seeking a designation as an eligible telecommunications carrier under 47 U.S.C. Section 214(e)(2) of the Communications Act of 1934. A Protest to the application was filed by the Rural Telephone Coalition of Nebraska  $(RTCN)^1$  and the Rural Independent Companies  $(RIC)^2(\text{collectively referred to as the Protestants})$  on November 28, 2005. A petition of informal intervention was filed by N. E. Colorado Cellular, Inc., d/b/a Viaero Wireless on November 18, 2005.

On December 8, 2005, a Hearing Officer Order was entered which established a procedural schedule for the administration of this docket. In accordance with the procedural schedule, discovery objections were to be served on December 23, 2005. An oral argument on discovery objections was to be held on January 3, 2006.

However, after discovery was served, the Commission received notice that the parties reached an agreement. No discovery objections were filed. A discovery stipulation was filed by counsel for the Protestants on December 30, 2005. Upon review of the stipulation, the Hearing Officer finds that it should be approved. The oral argument previously set for
